Please try and be at our next couple of Stated meetings. The Worshipful Master has a lot of items to talk about and needs your input and the craft needs to vote on it.

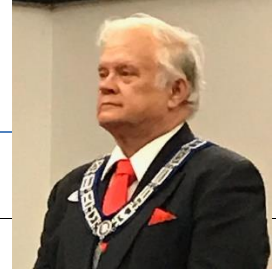

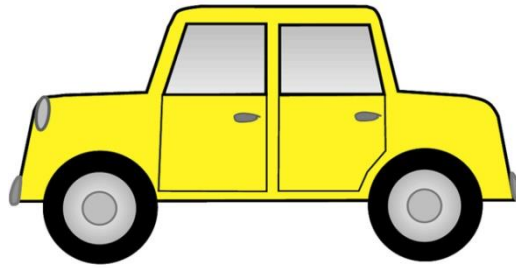
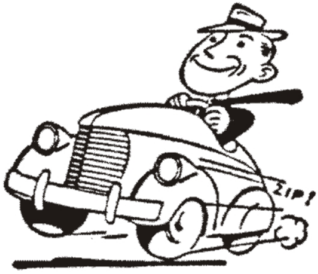
